Morgan Lewis Adds 4 Nonprofit And Philanthropy Attys In NY

Law360 (March 23, 2021, 3:59 PM EDT) -- Morgan Lewis & Bockius LLP has snagged four lawyers from Patterson Belknap Webb & Tyler LLP's philanthropic and nonprofit team, Morgan Lewis has confirmed.

Partners Megan Bell and Tomer Inbar, of counsel Lauren Simpson and associate Casey Oetgen join Morgan Lewis' current eight-lawyer tax-exempt organizations practice in New York at a time when nonprofits and charities have multiplied their activities because of the pandemic and resulting economic crisis and are increasingly collaborating with for-profit companies.

Bell, who will be a co-leader in Morgan Lewis' corporate social responsibility practice, specializes in advising philanthropic organizations as well as trade and agricultural associations. She focuses on corporate governance, internal and regulatory investigations, and lobbying, and like Inbar she advises for-profit companies in their dealings with nonprofits.
